In the reference 8th cited, the Secretary/Correspondent, Manjeera High School, Muthangi(V), Patancheru Mandal, Sangareddy District has submitted the proposals for granting Recognition to Pre-Primary Classes for the years from 2017-2018 to 2026-2027 in respect of Manjeera High School, Muthangi(V), Patancheru Mandal, Sangareddy District. In the reference 7th cited, the competent authority have accorded ETR to the existing school for Classes I to VII (E/M) for the years from 2008-2009 to 2017-2018 and 2018-2019 to 2027-2028.

The Managements of the Private schools have requested the Commissioner & Director of School Education, Telangana, Hyderabad to accord permission/Recognition to the Pre Primary classes running in the existing schools without any further inspection as their schools are enjoying recognition for a period of 5/10 years for higher classes. Accordingly, the Commissioner and Director of School Education, Telangana, Hyderabad conducted meeting with the representatives of the Private School Management Association and certain DEOs in the State on 28-04-2017. The Private schools Managements have informed that they shall give affidavit on non judiciary stamp paper duly notarized that they will abide by the Acts, Rules and Regulations in force viz. Education Act 1982, G.O Ms No 1 Edn Dated: 1-1-1994, Capitation Fee Act 5 of 1983 and other Rules, Regulations and Amendments issued from time to time by the State of Telangana and if any of the conditions submitted in the affidavit are held false at a later date and in case, any unforeseen incidence occurs, they will take personal responsibility and without giving any further notice, the Management shall be made responsible and are liable for criminal action besides withdrawal of the recognition of the school.

Accordingly, as per the instructions issued by the Govt in the G.O 1st and 2nd read above and the instructions issued by the Government in the Govt. memo 3rd and 5th read above and as per the instructions issued by the Comm. & Director of School Education, Telangana, Hyderabad in the procs 4th and 6th read above, the existing private schools who have already paid inspection fee of Rs 10,000/- before the due date ie. 10-03-2017,




uploaded the information online and submitted soft copy along with other information as per the instructions of the government, and submitted affidavit and photographs of the school, the District Educational Officer, Sangareddy is pleased to accord Recognition to pre Primary Classes (Play Group to UKG) (EM) for the years 2017-2018 to 2026-2027 in respect of Manjeera High School, Muthangi(V), Patancheru Mandal, Sangareddy District, subject to fulfillment of the following conditions.

1. The Pre Primary classes shall be established in well ventilated buildings only and they should be run preferably in Ground Floor only. The Building shall be located away from the commercial establishments, overcrowded areas like markets, bars, toddy shops, wine shops, cinema halls etc and away from natural barrier as per rules in vogue.
2. The building shall be provided proper compound walls.
3. They shall provide necessary play items made up of non hazardous material and shall not have sharp edges and they shall be age appropriate.
4. Provide sufficient separate staff including ayahs to take care of the children or pre- primary classes etc
5. The management shall abide by the terms and conditions as submitted by them in the affidavit on non judiciary stamp paper duly notarized.
6. They shall also take following safety measures:
 - a) Provide necessary infrastructure like class rooms, sanitation facilities, drinking water facilities, and first aid facilities etc as per the norms.
 - b) Provide sufficient number of trained Ayahs and other supporting staff to fulfill the needs of the children and for the safety and security of the children.
 - c) Where ever transportation facilities are provided for bringing the children from their home and for dropping them from school to home, they shall provide necessary parking, trained personnel for driving, helpers etc for guiding the children and also they shall accompany the children in the bus during journey.
7. Apart from the above, they shall implement all other conditions as may be prescribed by the government from time to time.

The Correspondent is informed that if any of the conditions submitted in the declaration are held false at a later date and in case, any unforeseen incidence occurs, Management have to take responsibility and without giving any further notice, the Management is liable for criminal action besides withdrawal of the recognition of the school.
